As Yogi Said, "It Ain't Over"

As baseball great Yogi Berra reportedly said, "The game ain't over 'til it's over." The recent SCOTUS decisions on marriage equality and the Affordable Care Act felt like the end of a long road, and indeed they were. Nonetheless, in the days, and perhaps even hours following those decisions, it became clear that the game wasn't over. There was going to be a lot of wrangling over just what the day-today, feet-on-the-ground working out of the decisions would mean, and should mean. In this somewhat more academic than usual column, I want to look at these questions in light of how people interpret the two religion clauses in first amendment to the U.S. Constitution.

Them wording seems simple enough on the surface: Congress shall make no

law respecting an establishment of religion, or prohibiting the free exercise thereof. It gets sticky when what seems to me to be an establishment of religion may well seem to someone else to be protecting their free exercise, and what seems to me to be a necessary protection for my free exercise of religion may well seem like an establishment to my neighbor.

Over all, Americans' views on the specifics of how the constitutional guarantees of religious freedom should be interpreted and applied show considerable ambivalence, ambiguity, and inconsistency. Many times, for many people, it's issuedependent rather than being consistent across issues.

Solar Panels Project and Needed Roof Repair

It's been a lively, wild, and sometimes stressful ride for the "Green Team" down this new solar road. Overall, however, although I've felt very indebted to this congregation and the UU movement in the past, right now that feeling is stronger than ever.

Here are a few reasons – which will also provide some background on recent and upcoming developments. Please read on.

1. SUN Grant Matching Funds

We were rather recently informed of one of the last requirements to "nail down" our \$30,000 SUN grant: by July 27, we had to send them several things including documented "proof of [not just a plan for] secured [not just "committed"] matching funds."

One component of our plan for matching funds (included in the Green Team's April 19 presentation to the congregation) was a special fund drive with a goal of \$11,500. We got busy calling in oral pledges and asking for some additional contributions. The response was so encouraging and gratifying: a total of \$14,800 from a select group of generous and dedicated members and friends. Thank you, thank you!

It may appear, at this time, that we have a surplus of funds. But we have been cautioned at a recent Board meeting about seemingly inevitable cost overruns on any sort of project like this. Also, allow me to state my personal opinion: these funds should be used, in good faith, exclusively for costs directly related to the solar panels project.

By the way, this whole process could not have been accomplished without the time-consuming and competent cooperation of new President **Sherry Ware** and new Treasurer **Usha Shivaswamy**. No slow and easy orientation for them. They hit the ground running hard.

2. The Completed Solar Installation Deadline of Dec. 31, 2015

All along, this non-negotiable deadline was Dec. 31. I gather that the "green" group of donors (the custodians of the settlement funds from I&M power company) wants those installations up and running before the 2016 session of the Indiana General Assembly. Period. OK, but at UUCM a couple things have to happen first. Read on.

3. Installation of a New Rubber Roof

As you've heard by now, a new and better solution to our nagging roof problem has just recently been found, that is, a new, light-weight but durable rubber membrane roof to place over the present one. But it needs to be done SOON before the solar panels go up. And although at \$49,000 it's around 1/3 the cost of a replacement asphalt "built-up" roof (the kind up there now), that sizeable financial commitment requires official congregational approval. Read on.

4. Another Special Congregational Meeting – soon, on Sunday, August 9, 12:15 pm

Bruce Craig and the Property Maintenance Committee will review the case for this new roof, already approved by the Board, and address your questions. Also, Chuck Austin, Finance Committee Chair, will be on hand to facilitate discussion of a plan (also already approved by the Board) for funding the new roof. Then the vote will follow. And, of course, we need a quorum. PLEASE plan to attend.

Why all this rushing and fussing? As I've said before, because of a \$30,000 grant, a likely opportunity to save a whole lot of money in the long term, an opportunity to strengthen UUCM's presence and leadership in the community, and because it's the environmental, just, and moral thing to do. President-Elect Holly Hanauer is more concise: "Let's move into the future with a dry building and clean energy!"

A Tour of the Chakra's



When it comes to interpreting the *establishment clause*, people tend to hold one of four broad points of view:

- Accommodationists hold that the government should help all religions, while protecting the heritage of Judeo-Christianity on which they believe the nation was founded, especially when government support for religion is symbolic rather than financial. They support, for example, manger scenes on public property at Christmas and Congress opening its sessions with prayer.
- Separationists hold that proper application of the guarantees of religious freedom means the government should not support any religion, and that the separation of church and state should be as absolute as it can be. They reject, for example, emphasizing Judeo-Christian values in public schools and financial assistance to religiously-sponsored schools.
- Nonpreferentialists believe government should support all religions equally, without special protection for Judeo-Christianity. There is room for all in the symbolic public square.
- There are also Christian nonpreferentialists who do not want their government to support religion generally but should nonetheless protect America's Judeo-Christian heritage. Occupancy of the public square, in other words, should favor Christianity. The former would support an interfaith or multifaith National Day of Prayer observance. The latter would limit participation in such an observance to representatives of Christian denominations.

When *free exercise clause* issues arise, Americans usually take one of two positions:

- Communitarians, as the word suggests, would allow people to act on what they believe, but only as long as their actions do not offend the prevailing cultural or moral sensibilities of the community. If a religious practice violates the norms of the community, it can properly be curtailed.
- Libertarians support a much wider range of religious practice. Even if a practice violates prevailing cultural norms and values, it can be allowed unless it violates very basic human rights. For example, most libertarians would disallow human sacrifice while allowing nude rituals.

A couple of additional things happen when the two clauses interact with each other as people think about their positions on issues:

- Religious minimalists are very committed to non-establishment, to no government support for religion. They are equally skeptical of public free exercise. They oppose, for example, itinerant preachers preaching on college campuses and student religious groups using school property for meetings (when non-religious groups are permitted to do so).
- Religious free-marketeers would allow all religious groups to compete freely for adherents as long as there is absolutely no government support involved. For example, they oppose public displays of religious symbols, funding for military chaplains, teaching creationism in public schools, and public school prayer, no matter what religion is doing the praying.

So how does it look when we use this framework to think about the working out of the marriage equality decision? How *should* it look? Will clergy be required to marry same-sex couples even if doing so violates their religious beliefs? What about judges or justices of the peace who officiate for weddings? Can a court clerk refuse to issue a marriage license to same-sex couples if the clerk's own religious beliefs would prohibit doing so? Can a local florist, caterer, or wedding venue refuse service to same-sex couples?

The answer to the first question is clearly "no." Clergy are protected by a conscience clause. The other three questions are murkier. The judge or JP is a *public* servant. So is the court clerk. The providers are public businesses who can reasonably be expected to serve the *whole* public. There is an interesting blog on this topic at http://goo.gl/KYgOz9. I recommend it strongly, whatever you may think of his viewpoint. The comments are of interest as well.
