### Stewardship Committee

# Vice President's Report January 9, 2019

- Performed updates to and maintenance on the website. There has been an issue with the Sermons page in that it keeps "unpublishing" itself. I have worked with the hosting company support to resolve the issue.

- Asked Eleanor Johnson about changing the "Visitor Check Request Box" label to something other than sounding like we are paying visitors to attend.

- Distributed an electronic copy of the safety book I acquired at the seminar I attended.

- Coordinated the Youth Safety Task Force to meet next Tuesday 1/15 at 6:00 in the Red Room

- Program Council did not meet due to the split meeting between the holidays (happened week before last Board meeting)

- Christmas Eve was pretty well attended. Fellowship is done with scheduled events until summer's ice cream social.

- Social Justice Committee has a new member as Katie Williams has joined.
- Stewardship is preparing for the big kickoff day on Feb 3.
- Hospitality continues to do well
- Sights & Sounds and RE classes have been doing well as well.

# Past President's Report January 9, 2019

My main activity in the past month was to chair a meeting of the Sabbatical Event Committee that established congregation activities and dates for the sabbatical period.

# Treasurer's Report January 9, 2019

Our pledges and gifts remain down vs. last year (\$151,751 vs. \$175,584 last year). We are down about \$24,000, of which \$14,000 last year was the Bridge the Gap income. Bazaar income is also down vs. last year (\$14,023 vs. \$18,493). (Income and Expense vs. Prior Year)

Pledges are at 55% of budget. Loose offerings are also below expected at \$1098 vs. \$2087 budgeted. (Income and Expense vs. Budget)

Our current income is a bit concerning because we are down on pledges, loose offerings, and fundraising. We may have to find a way to make up the difference because there is no extra in our budget at all. In addition, dedicated offerings are down (\$6,214 vs. \$7,178).

Indiana Trust transferred \$6,000 from the Ball Fund to the Checking Account for the sabbatical. This is not reflected yet on our financial statements because we don't have new quarterly information in from Q4 2018.

The RE, music, office, and property maintenance costs are all about the same as last year.

Denominational affairs is a lot lower due to our decision to pay less until our pledges go up.

Our checking account balance is \$19,414 vs. \$41,430 in 2018. (Balance Sheet)

Our Designated fund is much higher (\$75,916 vs. \$36,414 last year). This is because we deposited the Lilly Sabbatical grant and the Ball Fund \$6,000 into the Designated fund. (Balance Sheet)

Mary and I are presenting a proposal for designated fund management to the Finance committee this month. We will have a proposal for the board in February.
