Treasurer's Report January, 2020

Current Year - FY 2019-20

So far this year, we have received \$125,693 in pledges and gifts (including \$1,692 in loose offerings) vs. \$150,000 last year at this time. We have collected 47.5% of the expected pledges for the year, and we are ½ way through the year. I am following up with Christie to make sure we are still on track to hit our budget number. (Income and Expense v Prior Year)

Our Bazaar raised \$15,565 vs. \$14,882 last year! Other fundraising is lagging since we planned for \$7500 in "misc. fundraising", and we have brought in \$200 so far. (Income and Expense v Budget)

We earned \$2058 in interest and dividends vs. \$6720 for the full year budgeted (30.6%). This could be due to timing because the value is up.

Dedicated offerings are at \$4,060 vs \$10,500 budgeted for the full year (\$38.7%) Building use is at 100% of the budget (\$495 so far vs. \$500 budgeted for the full year).

Expenses are in line with expectations. Some expenses such as RE, are below budget, and some, like custodians, are above due to timing. Worship Associates are above last year due to their repair/replacement of microphone parts. Child care and nursery expenses are up, which means we have more kids needing more care!

Property maintenance expenses are above last year (\$29,442 vs \$48,555 budgeted for the full year) due to higher expense in repairs and upkeep (\$4,441 v. \$4,500 budgeted for the full year). This bucket includes expenses for carpet cleaning (which we do every year) along with some AC repair and light repair in the parking lot. The Property Maintenance budget isn't the same every month, so this isn't necessarily a bad sign. We have spent 60.6% of the full year budget (Income and Expense v. full year budget).

Our checking account balance is \$21,123 v.\$19,064 last year. (Balance Sheet). All investments are up – Ball fund to \$85,667 from \$75,735, Askren \$12,932 vs. \$11,673, Templar \$221,711 vs. \$200,057, Crosley \$60,405 vs. \$53,326 (Balance Sheet).
