Introduction – Letter Sponsored by Morning Discussion Group for UUA Consideration

The morning discussion group is requesting that the Board of Trustees send a letter to the UUA recognizing that science is essentially important regarding the COVID-19 situation and response. Encouraging the UUA to make a public stand on the side of the truth of science.

Suggestion to perhaps publish in the UU World magazine Further suggestion that the statement should be more public

Communicate that not all religious organizations are relying on faith to make it through the COVID-19 situation and response

We know that there are churches who are still meeting and relying on faith.

What is the most effective method?

Suggestion that we submit for publication in the op-ed section of local newspapers that there is a religious community that endorses science as the best response to COVID-19

It is important to take a stance. It also may be a potential outreach tool to people who may not know there is a religious community who relies on science in juxtaposition to faith

We need to state why we are taking the stance. Because we feel it is a moral issue.

# Treasurer's Report April 7, 2020

Currently we have \$18,694 in our checking account vs. \$6,808 last year. (Balance Sheet)

So far, \$202,858 in pledges has come in or 70% of the full year goal of \$289,883. We are 77% of the way through the year. I don't know if that means we are behind, or if pledges will come in later. (Income and Expense)

Our operating expenses are on track at \$85,801 or 76% of the full year amount.

There are a lot of unknowns including: how will unemployment, market changes, and shelter at home effect our pledges, how will the market changes effect our income and dividends, how much will loose offerings go down since we can't use cash, etc.

We do know for sure that our fundraising income will be down. The Service Auction leaders and the Fundraising Committee have announced that they service auction will be moved to fall due to not having in person gatherings. This means that the income from that event will not come in this fiscal year (which ends June 30). So, that means we will reduce our fundraising by (estimated):

\$5,000 budgeted for the Service Auction \$4,500 additional fundraising budgeted

So, this will lead our budget to be \$9,500 short all other things being equal. We just don't know that all other things will be equal.

#### Other notes:

- Caroline is reminding Jim that he has \$3,731 in the Music Discretionary Fund to spend as he sees fit
- We have \$809 in the Flagpole fund to be used by the social justice committee, probably in the 2020-21 fiscal year due to the shutdown.
- Cathy will combine the Pastoral Care account and the Caring Fund when she does the Q1 books.

The requested, austerity, and recommended budgets are ready for discussion at the 4/16 Board meeting. We will present the budget for questions (via zoom) to the congregation on 4/26.

Christie is sending out pledge statements tomorrow and we were thinking about including something like this statement.

Let me know your thoughts tonight.	

I hope that this reminder finds you safe and healthy in this difficult time!

Remember, you can always mail your payments to the church office, but if you prefer to pay from your bank account without a check, please contact Christie to make arrangements. If you are struggling financially as a result of this crisis, we understand. Please call Christie or I to talk about your pledge.

We look forward to a time that we can all be together in one room again. In the mean time, take care!
